
Lt. Jay Leach acted as a judge for the Veteran's Day BBQ Cook Off for Fort. Cavazos.

COMMERCIAL DEVELOPMENT

The City issued three (3) commercial construction permits within the month of September.

To date (September 30, 2023) the City has issued a total of seventeen (17) commercial permits totaling 8,630,000.00 in project valuation for calendar year 2023.

RESIDENTIAL DEVELOPMENT

The City issued a total of **three** (3) permits for <u>single-family residential</u> construction within the month of September.

The City issued a total of **three** (3) permits for <u>two-family (duplex) residential</u> construction within the month of August.

To date (September 30, 2023) the City has issued a total of one-hundred eighty (180) residential permits, one-hundred nine (109) single-family permits, seventy-one (71) two-family permits, and zero (0) multifamily permits in calendar year 2023.

As of September 30, 2023, the estimated population for the City of Harker Heights is <u>35,420</u> residents. According to the US Census, the population as of April 1, 2020 was 33,097 residents. Since that time, we have added 782 new water accounts with an average household size of 2.97.

COMMERCIAL DEVELOPMENT

The City issued zero (0) commercial construction permits within the month of October.

To date (October 31, 2023) the City has issued a total of seventeen (17) commercial permits totaling \$8,630,000.00 in project valuation for calendar year 2023.

RESIDENTIAL DEVELOPMENT

The City issued a total of **eighteen** (18) permits for <u>single-family residential</u> construction within the month of October.

- 17 Single Family permits in The Village at Nolan Heights
- 1 Single Family permit in Salazar Subdivision

The City issued a total of **three** (3) permits for <u>two-family (duplex) residential</u> construction within the month of October.

- 2 Two-Family permits in Comanche Land
- 1 Two-Family permit in Cox Addition

To date (October 31, 2023) the City has issued a total of two-hundred one (201) residential permits, one-hundred twenty-seven (127) single-family permits, seventy-four (74) two-family permits, and zero (0) multi-family permits in calendar year 2023.

As of October 31, 2023, the estimated population for the City of Harker Heights is <u>35, 384</u> residents. According to the US Census, the population as of April 1, 2020 was 33,097 residents. Since that time, we have added 770 new water accounts with an average household size of 2.97.
