#### NATIONAL DISTRACTED DRIVING MONTH - APRIL 2021

WHEREAS; the National Highway Traffic Safety Administration (NHTSA) has declared the month of April 2021 as National Distracted Driving Month; and

WHEREAS; distracted driving is any activity that diverts attention from driving, including talking or texting on your phone, eating and drinking, talking to people in your vehicle, adjusting the entertainment or navigation system; and

WHEREAS; you cannot drive safely unless the task of driving has your full attention and any non-driving activity is a potential distraction and increases your risk of crashing; and

WHEREAS; distracted driving killed 3,142 people in 2019, an increase of 10% from 2018; and

WHEREAS; distracted driving is the No. 2 reason for traffic related crashes on Texas roadways causing 1 in 5 crashes in 2020 in which 364 people died and 2,200 were seriously injured; and

WHEREAS; since September 1, 2017 it has been illegal to read, write, or send a text while driving in Texas, with fines of up to \$200 for violators; and

WHEREAS; the Texas Department of Transportation (TxDOT) and the Harker Heights Police Department is fully committed to ending all traffic related deaths on Texas roads and is reminding all Texans to put their phones down and give driving their full attention whenever they are behind the wheel;

DISCUSS AND CONSIDER APPROVING AN ORDINANCE OF THE CITY OF HARKER HEIGHTS, TEXAS, AMENDING ORDINANCE 2020-06 OF THE HARKER HEIGHTS CODE TO EXTEND THE COVID-19 PUBLIC HEALTH EMERGENCY DECLARATION THROUGH JUNE 3, 2021, AND TAKE THE APPROPRIATE ACTION.

#### **EXPLANATION:**

The State of Texas and Bell County both have issued disaster declarations that cover Harker Heights in relation to the COVID-19 pandemic. According to the Texas Municipal League (TML) guidance on receiving reimbursements in relation to COVID-19 expenditures, Mayor Smith issued a disaster declaration for the City of Harker Heights on March 20, 2020.

The City Council approved an Ordinance during a special called meeting on April 7, 2020, to extend the Public Health Emergency Declaration to April 30, 2020.

On April 28, 2020, the Council approved an extension to the Public Health Emergency Declaration until May 31, 2020.

On May 26, 2020, the Council approved an extension to the Public Health Emergency Declaration until June 30, 2020.

On June 23, 2020, the Council approved an extension to the Public Health Emergency Declaration until July 31st, 2020.

On July 28, 2020, the Council approved an extension to the Public Health Emergency Declaration until August 31, 2020.

On August 25, 2020, the Council approved an extension to the Public Health Emergency Declaration until September 30, 2020.

On September 22, 2020, the Council approved an extension to the Public Health Emergency Declaration until October 31, 2020.

On October 27, 2020, the Council approved an extension to the Public Health Emergency Declaration until January 31, 2021.

On January 26, 2021, the Council approved an extension to the Public Health Emergency Declaration until March 2, 2021.

On February 23, 2021, the Council approved an extension to the Public Health Emergency Declaration until April 2, 2021.

On March 23, 2021, the Council approved an extension to the Public Health Emergency Declaration until May 3, 2021.

Action is now needed again by the Council to consider extending this declaration to match recent directives from the State and Bell County out to June 3, 2021.

This declaration continues to align with the City's COVID-19 response measures to those issued by Bell County and the State. If Bell County or the State modify their orders, then the City's requirements would automatically reflect these modifications, to include the Governor's staged initiatives of "Reopening Texas".

The Council may at any time choose to end, modify, and/or extend the declaration.

#### STAFF RECOMMENDATION:

Staff recommends approval of the extension.

AN ORDINANCE OF THE CITY OF HARKER HEIGHTS, TEXAS, AMENDING ORDINANCE 2020-06 OF THE HARKER HEIGHTS CODE TO EXTEND THE COVID-19 PUBLIC HEALTH EMERGENCY DECLARATION THROUGH JUNE 3, 2021.

WHEREAS, the City Council ("Council") of the City of Harker Heights ("City") finds that it is necessary and desirable to amend the Code of Harker Heights ("Code") as hereinafter provided in order to extend the Public Health Emergency Declaration; and

WHEREAS, the meeting at which this Ordinance was passed was open to the public, and notice of the time, place and purpose of said meeting was given as required by law, all in strict accordance with the requirements of the Texas Open Meetings Act;

#### **EXPLANATION:**

On February 12, 2021, Texas Governor Greg Abbott certified that a severe winter storm posed an imminent threat of widespread and sever property damage, injury, and loss of life due to prolonged freezing temperatures, snow, freezing rain, and ice. Governor Abbot further declared a state of disaster for all 254 counties in the State of Texas. Bell County Judge David Blackburn declared a state of emergency in the County and announced the closure of non-essential county offices on February 15, 2021.

The City of Harker Heights, along with the entire region, has iced-over roads, and loss of electric, gas, telephone and water utility services caused by extreme winter weather and freezing conditions presenting a threat of widespread or severe damage, injury, or loss of life and property.

Under the authority granted to the Mayor of Harker Heights, Spencer H. Smith declared a state of disaster on February 16, 2021, for the City of Harker Heights. The Declaration implements the City's Emergency Management Plan in which the City can acquire all resources needed to protect life and property for the winter weather.

On February 23, 2021, the Council affirmed the Mayor's State of Disaster Declaration and extended the winter storm emergency declaration until March 23, 2021.

On March 23, 2021, the Council approved an extension to the Winter Storm Disaster Emergency Declaration to April 30, 2021.

Action is now needed again by the Council to consider extending the Winter Storm Declaration out to May 30, 2021.

#### **RECOMMENDATION:**

Staff recommends approval of the extension.

#### **EXPLANATION:**

Per the Texas Attorney General's opinion No. GA-0526 (2007), a home-rule municipality, through their city ordinance, may prohibit registered sex offenders from living within a specified distance from locations where children typically congregate. This is often accomplished through the establishment of "child safety zones". Per Local Government Code §341.096(a)(3)(d) the maximum distance for a child safety zone is 1,000 linear feet measured in a direct line between property lines.

#### **ANALYSIS**

In summary, the attached ordinance acts to regulate sex offender residency in the following manner:

- 1. Establishing child safety zones within the city;
- 2. Prohibiting permanent residency, temporary residency, or habitation within the child safety zone;
- 3. Establishing an offense for a sex offender to knowingly, within the city limits, enter onto the premises of:
  - a. private and public schools;
  - b. child daycare centers;
  - c. private and public playground;
  - d. public or private youth center;
  - e. commercial and public swimming pools;
  - f. video and amusement arcades;
  - g. private and public parks;
  - h. indoor and outdoor amusement centers catering primarily to minors; and
  - i. amusement parks;

- 4. Prohibiting trick-or-treat participation by a registered sex offender; and
- 5. Establishing civil and criminal penalties.

As written, the ordinance provides necessary enforcement options for the regulation of sex offender residency and allows the Police and Code Enforcement departments to apply violations of the Code.

#### STAFF RECOMMENDATION:

Staff recommends approval of an ordinance of the City of Harker Heights setting forth regulations for sex offender residency; providing definitions; creating "child safety zones"; prohibiting the establishment of residences and certain activities by sex offenders in child safety zones; providing affirmative defenses; establishing other provisions relating to mental state and non-assumption of duties; providing a severability clause; providing a penalty and providing an effective date.

WHEREAS, the City of Harker Heights, Texas ("City of Harker Heights") is a home rule city; and

WHEREAS, the City Council of the City of Harker Heights has determined and declares that sex offenders are a threat to public health, safety, welfare and morals; and

WHEREAS, the City Council determines that a policy establishing child safety zones to be applied regarding the residence of registered sex offenders and prohibiting registered sex offenders participating in Halloween will provide better protection for children within the City of Harker Heights; and

WHEREAS, the City Council, in accordance with the Charter of the City of Harker Heights, state law and all other applicable laws and ordinances, have given required notices and have held required public hearings regarding the amendment to the Municipal Code set forth herein; and

WHEREAS, the Council desires to provide for the health, safety, morals, and general welfare of the citizens of the City of Harker Heights by and through the exercise of its police powers;

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HARKER HEIGHTS, TEXAS AS FOLLOWS:

Section 1. All of the above premises are found to be true and correct legislative findings of the City of Harker Heights and are hereby approved and incorporated into the body of this Ordinance as if copied in its entirety.

<u>Section 2.</u> Title XIII of the Code of Ordinances of the City of Harker Heights is hereby amended by establishing Chapter 132 "Regulation of Sex Offender Residency" as follows:

#### CHAPTER 132 - REGULATION OF SEX OFFENDER RESIDENCY

#### Sec. 132.01. - Definitions.

For purposes of these regulations the following terms, words, and derivations thereof shall have the meanings given herein:

Child. See minor.

Child safety zone. Shall mean a zone extending 1,000 feet from the property line of the following facilities: private and public schools, child daycare centers, private and public playground, public or private youth center, commercial and public swimming pools, video and amusement arcades, private and public parks, indoor and outdoor amusement centers catering primarily to minors, and amusement parks. The zone includes the facilities themselves.

Day care center. Shall mean a childcare facility that is registered, licensed, or listed by the state.

Minor. Shall mean a person younger than 17 years of age.

*Permanent residence*. Shall mean a place where a person abides, lodges, or resides for 14 or more consecutive days.

*Person.* Shall mean an individual, firm, partnership, corporation, company, association, syndicate, or any legal entity, whether he, she, or it is acting for himself, herself, or itself or as the servant, employee, agent or representative of another.

*Playground.* Shall have the meaning assigned by V.T.C.A., Health and Safety Code chapter 481.134, as amended.

Temporary residence. Shall mean a place where a person resides, lodges, or abides for a period of four or more consecutive or nonconsecutive days in any month, or for a period of less than 14 days in the aggregate during any calendar year, which is not the person's permanent residence.

*School.* Shall have the meaning assigned by V.T.C.A., Health and Safety Code chapter 481.134, as amended.

Sex offender. For purposes of this chapter, shall mean a person required to register on the state department of public safety's "public" sex offender database under V.T.C.A., Code of Criminal Procedure chapter 62 due to a reportable conviction or adjudication involving a victim younger than 17 years of age or a person who has been civilly committed as a sexually violent predator under V.T.C.A., Health and Safety Code chapter 841 and is subject to outpatient treatment and supervision under that chapter.

Video and Amusement Arcades. Shall have the meaning assigned to video arcade facility by V.T.C.A., Health and Safety Code chapter 481.134, as amended.

Youth Center. Shall have the meaning assigned by V.T.C.A., Health and Safety Code chapter 481.134, as amended.

#### Sec. 132.02. - Offenses.

- (a) It is unlawful for a sex offender to establish a permanent or temporary residence within the child safety zone as defined in section 132.01.
- (b) It is unlawful to lease, rent or otherwise provide any residence, dwelling, place, structure (or part thereof), manufactured home, trailer, or other habitation located in a child safety zone to a sex offender with the knowledge that it will be used as a permanent or temporary residence by such person.
- (c) It is an offense for a sex offender to knowingly enter onto the premises of private and public schools, child daycare centers, private and public playground, public or private youth center, commercial and public swimming pools, video and amusement arcades, private and public parks, indoor and outdoor amusement centers catering primarily to minors, and amusement parks within the city limits of the city.
- (d) A sex offender shall not leave on an exterior light or otherwise invite trick-or-treaters to solicit a permanent or temporary residence between the hours of 4:00 p.m. and 11:00 p.m. on each October 30 and 31, or any specific date set by the City Council for trick-or-treaters.

#### Sec. 132.03. - Evidentiary matters; measurements.

- (a) It shall be prima facie evidence that this article applies to such a person if that person is a sex offender as defined in section 132.01.
- (b) For the purposes of determining the minimum child safety zone separation, the following shall apply:
  - (1) The distance shall be measured by following a straight line from the nearest property line of the permanent or temporary residence to the nearest property line of the facility where the child safety zone applies.
- (c) A map, available in the city police department, depicting the child safety zones in the city shall be maintained and reviewed annually for changes by the city.

#### Sec. 132.04. - Culpable mental state not required.

Neither allegation, nor evidence, of a culpable mental state is required for the proof of the offense defined by this chapter under subsection 132.01(a) or subsection 132.02(d).

#### Sec. 132.05. - Affirmative defenses.

It is an affirmative defense to prosecution that any of the following conditions apply:

- (2) The person required to register on the database was a minor when he or she committed the offense requiring such registration and was not convicted as an adult.
  - (3) The person required to register on the database is a minor.
- (4) The facility to which the child safety zone applies was opened after the person established a permanent or temporary residence and the person is compliant with all sex offender registration laws of the state.
- (5) The information on the database is incorrect, and if corrected, this chapter would not apply to the person who was erroneously listed on the database.

Section 3. If any section, article, paragraph, sentence, clause or phrase of this Ordinance or the application thereof to any person or circumstances is held invalid or unconstitutional by a court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portion shall remain in full force and effect.

<u>Section 4.</u> Any person who intentionally or knowingly violates or fails to comply with any provision of this Ordinance shall be fined, upon conviction, in an amount not to exceed \$2,000.00, and each day any violation continues shall constitute a separate offense.

#### Currently:

(F) Containers shall be removed from the front of the premises by the owner, occupant, tenant, or lessee no later than 11:00 p.m. on the evening of the collection.

#### Recommendation:

(F) Containers shall be removed from the public right-of-way by the owner, occupant, tenant, or lessee no later than 11:00 p.m. on the evening of the collection.

#### Currently:

(G) Except on the designated collection day, solid waste containers shall be stored not closer to the nearest public road than the front of the house or building from where collection is made, provided that if the house or building is situated more than 200 feet from the nearest public road, the containers may be stored at any location which does not pose a hazard and is not visible from the nearest public road.

#### Recommendation:

(G) Except on the designated collection day, the containers may be stored at any location which does not pose a hazard.

#### **RECOMMENDATION:**

Staff recommends approval.

- (F) Containers shall be removed from the public right-of-way by the owner, occupant, tenant, or lessee no later than 11:00 p.m. on the evening of the collection.
- (G) Except on the designated collection day, the containers may be stored at any location which does not pose a hazard.

**SECTION 3:** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are to the extent of such conflict hereby repealed.

SECTION 4: All of the regulations provided in this ordinance are hereby declared to be governmental and for the health, safety and welfare of the general public. Any member of the City Council or any city official or employee charged with the enforcement of this ordinance, acting for the City of Harker Heights in the discharge of official duties, shall not thereby become personally liable, and is hereby relieved from all personal liability for any damage that might accrue to persons or property as a result of any act required or permitted in the discharge of said duties.

**SECTION 5:** This ordinance shall be effective from and after its passage, and the City Clerk shall publish the caption or title of hereof within ten days as required by law.
