1. The accessory dwelling unit shall be used as a living space for a relative (not for rent).
2. The accessory dwelling unit will be located behind the front façade of the primary structure.

RECEIVE AND DISCUSS THE FISCAL YEAR 2021-2022 SECOND QUARTER INVESTMENT REPORT.

EXPLANATION:

Attached is the investment report for the second quarter of fiscal year 2022. The total amount invested as of March 31, 2022, was \$41,874,274.64. This is \$8,708,103.99 more than the \$33,166,170.65 that was held by the City as of March 31, 2021.

As shown in the table above, total investments increased by \$4,807,571.54 from the first quarter of the 2022 fiscal year. Transactions during the second quarter include the following activity:

1. The General Fund's maintenance and operations portion of the property tax payments received during the second quarter totaled \$4,782,107.
2. The Utility Fund made \$1,500,000 in transfers to other funds during the first quarter; no transfers out were made during the second quarter.
3. The Capital Projects Fund made payments for projects to include the Wastewater Bar Screen Improvements, the 2021 Street Improvement Project, Warrior's Path Phase 2, sewer rehabilitation projects, and the sidewalk projects.
4. The Debt Service Fund's interest and sinking portion of property tax payments received during the second quarter totaled \$1,375,530. In February 2022, debt payments were made.
5. The Restricted Court Fund completed its budgeted transfers of \$83,500 to the General Fund.
6. The Coronavirus Fund funded the following:
 - a. from Coronavirus Relief Funds - tactical shields, vehicles, and radios.

- b. from Coronavirus State and Local Relief Funds - Rummel Road Lift Station Upgrade and Second Belt Press Installation.

Interest rates for the investments listed on the attached Investment Report average 0.207% for those with a maturity range within one month's time and average 0.247% for those maturing within nine to twelve months. Two investments maturing within one year are at 1.05% and 1.10%. As a comparison, Treasury bill rates on March 31, 2022 for a one-month investment was 0.17% and for a one year investment was 1.61%. As shown on page 6 of the report, the City currently does not have any investments that exceed a maturity range of one year and none of the investments are callable.

The City currently has investments with the Bank of China, Bank of India, and State Bank of India all located in New York, NY. These investments are allowable by the City's Investment Policy and the Public Funds Investment Act based on the following: they are (1) invested through our approved broker/dealer, Stifel Nicolaus, (2) our broker/dealer arranged the deal with Staff approval, (3) the full amount of the principal and accrued interest is insured by the Federal Deposit Insurance Corporation (FDIC), and (4) the City has a designated depository bank to act as the custodian for the transactions.

The majority of the City's funds were available within the 0-1 month time frame with 74.97% of the portfolio in this category as of March 31, 2022. Three certificates of deposit matured in April; one on April 14th with an interest rate of 0.25% and two on April 27th with interest rates of 0.10% and 0.20% each.





Title VII Transportation Code, Chapter 72, Stopping, Standing, and Parking has been updated to reflect updated State Laws governing parking regulations in subchapter 72.11 Where No Signs Required.

Title VII Transportation Code, Chapter 74, Traffic Schedules has been updated to reflect changes in street names, speed limits, and school zone parameters as they currently exist in the city under Schedule I Speed Limits ; Schedule II School Zones ; Schedule III One-Way Streets ; Schedule IV Through Streets ; Schedule V Stop Signs ; Schedule VI Yield Signs ; Schedule VII Traffic-Control Signals.

GENERAL PROVISIONS

§ 70.01 SHORT TITLE.

This title may be known and cited as the “Transportation Code.”

§ 70.02 DEFINITIONS.

(A) Specific definitions. For the purpose of this transportation code, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

COMMERCIAL VEHICLE. Every vehicle that is primarily engaged in the transportation of cargo, passengers, or equipment for consideration.

DESIGNATED OFFICIAL. The Chief of Police, or in the absence of the Chief of Police, the Operation Manager or designated representative.

FREIGHT CURB LOADING ZONE. A space adjacent to a curb which is reserved exclusively or primarily for the use of vehicles during the loading or unloading of materials, freight, equip-ment, or other non-passenger cargo.

PASSENGER CURB LOADING ZONE. A space adjacent to a curb which is reserved exclusively or primarily for the use of vehicles during the loading or unloading of passengers.

POLICE OFFICER. Every peace officer employed by the City Police Department or any other person authorized by law to direct or regulate traffic, or to issue citations or make arrests for violations of traffic regulations.

POLICE CHIEF. The City Police Department’s highest ranking Police Officer who is appointed by the City Manager or City Council or their designee.

TRAFFIC MANAGEMENT UNIT. The Traffic Management Unit of the City Police Department, provided that in the event that no traffic management unit has been established by the Department, then the term shall mean the City Police Department.

(B) Time. All references to a specified hour shall be deemed to refer to Central/Standard time, or daylight savings time, whichever may at that time be in general use throughout the city.

(C) Whenever any words or phrases used in this transportation code are not defined in this section, but are defined in current statutes promulgated by the Texas Legislature regulating traffic or the operation of vehicles, such definitions shall apply to the words and phrases used herein, except when the context requires otherwise.

(D) Whenever any words or phrases used in this transportation code are not defined in this section or by other legislation as described in division (C) above, such words or phrases shall have the meanings commonly ascribed to them.

TRAFFIC-CONTROL DEVICES

§ 70.20 AUTHORITY TO INSTALL.

The designated official shall place and maintain official traffic control signs, signals and devices when and as required under the traffic ordinances of this city to make effective the provisions of the ordinances. The designated official is also authorized to place and maintain such additional traffic control signs, signals, and devices as he/she may deem necessary to regulate, warn or guide traffic for the protection of citizens and/or the promotion of the orderly flow of traffic within the City.

§ 70.21 MANUAL AND SPECIFICATIONS.

All traffic-control signs, signals, and devices shall conform to the Texas Manual on Uniform Traffic-Control Devices, , as amended. All signs and signals required hereunder for a particular purpose shall so far as practicable be uniform as to type and location throughout the city. All traffic-control devices so erected and not inconsistent with the provisions of state law or this transportation code shall be official traffic-control devices.

§ 70.27 TRAFFIC-CONTROL SIGN INVENTORY.

An inventory of all traffic-control signs installed shall be maintained by the city. The inventory shall include the following information: 1) Type of Sign 2) Roadway on which the sign is located 3) Intersecting roadway 4) Travel Direction 5) Date of Installation. Further installations, removals or maintenance of the traffic control signs shall be entered in the inventory as they occur. It shall not be required that there be included in Chapter 74 of the Code of Ordinances a schedule of each stop sign or yield sign erected in the City of Harker Heights.

§ 70.28 UNAUTHORIZED SIGNS UNLAWFUL.

Shall be defined and enforced as described in the Texas Transportation Code, as amended.

§ 70.29 DEFACING SIGNS UNLAWFUL.

Shall be defined and enforced as described in the Texas Transportation Code, as amended.

ADMINISTRATION AND ENFORCEMENT

§ 70.40 AUTHORITY OF POLICE AND FIRE DEPARTMENT OFFICIALS.

(A) It shall be the duty of the officers of the Police Department or such officers as are assigned by the Chief of Police to enforce all street traffic laws of this city and all of the state vehicle laws.

(B) Officers of the Police Department or such officers as are assigned by the Chief of Police are hereby authorized to direct all traffic by voice, hand, or signal in conformance with traffic laws, provided that, in the event of a fire or other emergency or to expedite traffic or to safeguard pedestrians, officers of the Police Department may direct traffic as conditions may require notwithstanding the provisions of the traffic laws.

(C) Officers of the Fire Department, when at the scene of a fire, may direct or assist the police in directing traffic thereat or in the immediate vicinity.

(D) The Police Chief or their designee shall evaluate the placement of all traffic control signage prior to installation and such installation must be in compliance with the Texas Manual on Uniform Traffic Control Devices, as amended. Each traffic control sign that is approved by the Chief of Police or their designee shall add the approved traffic control device to the established sign inventory, including the following information: 1) Type of Sign 2) Roadway on which the sign is located 3) Intersecting roadway 4) Travel Direction 5) Date of approval 6) Date of Installation

§ 70.41 TRAFFIC MANAGEMENT UNIT.

(A) Duties. It shall be the duty of the Traffic Management Unit+ with such aid as may be rendered by other members of the Police Department to enforce the street traffic regulation of this city and all the state vehicle laws, to make arrest for traffic violations, to investigate accidents and to cooperate with the designated official and other officers of the city in the administration of the traffic laws and in developing ways and means to improve traffic conditions, and to carry out those duties specially imposed upon the Division by this transportation code and the traffic ordinances of this city.

(B) Investigation of accident. In the investigation of accidents, the Traffic Management Unit shall arrest and assist in the prosecution of those persons charged with violations of law causing or contributing to such accidents.

(C) Traffic accident studies. Whenever the accidents at any particular location become numerous, the Traffic Management Unit shall cooperate with the designated official in conducting studies of such accidents and determining remedial measures.

(D) Traffic accident reports. All Peace Officer crash reports will be submitted using the Texas Department of Transportation Crash Reporting Information System(CRIS) within ten days of receiving the crash report.

§ 71.04 STOP AND YIELD INTERSECTIONS.

(A) Whenever any ordinance of the city designates and describes a through street it shall be the duty of the designated official to place and maintain a stop sign, or on the basis of an engineering and traffic investigation at any intersection a yield sign, on each and every street intersecting such through street unless traffic at any such intersection is controlled at all times by traffic-control signals; provided however, that at the intersection of two such through streets or at the intersection of a through street and a heavy traffic street not so designated, stop signs shall be erected at the approached of either of the streets as may be determined by the designated official upon the basis of an engineering and traffic study.

(B) The city hereby designates certain non-scheduled intersections where a particular hazard exists as determined by a traffic investigation to be controlled by stop or yield signs for so long as such hazard is in existence.

Penalty, see § 71.99

(C) The designated official is further authorized to determine or designate any street intersection not included in §71.04(A) as a stop or yield intersection and to place and maintain a stop sign or yield sign at such intersection as and where the designated official determines it should be placed for the protection of citizen and/or the promotion of the orderly flow of traffic within the City.

(D). It shall be the duty of the driver of any vehicle approaching a stop sign to bring such vehicle to a complete stop at such time at such sign or at a clearly marked stop line before entering the intersection controlled by the stop sign, except when directed to proceed by a police officer or specially placed traffic control signal. After having so stopped, such driver shall yield right-of-way to other vehicles which have entered the intersection, or which are approaching so closely as to constitute an immediate hazard. It shall be the duty of the driver of any vehicle approaching an intersection controlled by a yield sign to exercise caution as it approaches such intersection and to yield right-of-way to vehicles or pedestrians crossing through or approaching to cross through such intersection.

DISCUSS AND CONSIDER APPROVING AN AMENDMENT TO THE ECONOMIC DEVELOPMENT INCENTIVE AGREEMENT WITH GAMBIT SOCIAL HOUSE, INC. ("GAMBIT") MODIFYING THE CONSTRUCTION COMPLETION DATE TO OCTOBER 31, 2022, FOR THE ADMINISTRATION OF ONE OR MORE PROGRAMS FOR MAKING GRANTS OR LOANS OF PUBLIC MONEY TO PROMOTE ECONOMIC DEVELOPMENT AND STIMULATE BUSINESS AND COMMERCIAL ACTIVITIES WITHIN THE CITY; AND AUTHORIZE THE CITY MANAGER TO SIGN THE AGREEMENT ON BEHALF OF THE CITY; AND TAKE THE APPROPRIATE ACTION. (ASSISTANT CITY MANAGER)

EXPLANATION:

The Council approved a 380 Agreement for Gambit Social House, Inc. during a regular scheduled City Council meeting on the 8th of June 2021. Due to the rain slowing down the progress early in the construction phase an extension was granted by the City Council to change the completion date from March 31, 2022 to June 1, 2022.

As a reminder, Chapter 380 of the Texas Local Government Code allows a City to establish and provide for the administration of one or more programs for making grants or loans of public money to promote economic development. The Agreement provides reasonable and adequate safeguards to ensure that the public receives sufficient benefits in exchange for the Incentives.

Gambit Social House has requested an extension for the completion date to be changed from June 1, 2022 to October 31, 2022 due to material shortages (lumber and technology supplies).

RECOMMENDATION:

Staff recommends approval.

ACTION BY THE COUNCIL:

1. Motion to APPROVE/DISAPPROVE amending the economic development incentive agreement with Gambit Social House, Inc., modifying the construction completion date to October 31, 2022, for the administration of one or more programs for making grants or loans of public money to promote economic development and stimulate business and commercial activities within the City; and authorize the City Manager to sign the agreement on behalf of the City.
2. Any other action desired.

ECONOMIC DEVELOPMENT GRANT AGREEMENT

This Economic Development Grant Agreement (“Agreement”) is entered into by and between the **CITY OF HARKER HEIGHTS, TEXAS** (“City”) and **GAMBIT SOCIAL HOUSE, INC.** (“Gambit”). The purpose of this Agreement is to set forth the terms under which the City will make certain economic development grants to Gambit.

The City is authorized by Chapter 380 of the Texas Local Government Code to establish and provide for the administration of one or more programs for making grants or loans of public money to promote economic development and stimulate business and commercial activities within the City. The grants described herein are made for that purpose.

The parties agree as follows:

I.

MAXIMUM GRANT LIMIT

1. The cumulative amount of grant payments to be made under this Agreement shall not exceed \$150,299.00. Once the cumulative amount of economic development grants (real property economic development grants plus sales related economic development grants) equals \$150,299.00, the City shall have no further obligation to pay grants under this Agreement and the Agreement will terminate.

II.

DESCRIPTION OF PROJECT – GAMBIT COMMITMENTS

1. Gambit agrees to construct taxable improvements as described herein on the tract of property located within the city limits of the City which is described on **Exhibit “A”** (“Premises”). The real property improvements and taxable personal property which are to be constructed, placed, and maintained on the Premises shall be referred to herein as the “Project Improvements.” These Project Improvements that Gambit agrees to construct shall include a 12,000 square foot entertainment venue which will house a beer tap room, restaurant, nine-hole miniature golf course, eight escape rooms and a 400 square foot event space. The Project Improvements that Gambit agrees to construct shall also include 3 outside axe throwing lanes, beach volleyball facilities, and other games and seating areas on the Premises. Gambit agrees to complete construction and placement of the Project Improvements having a value as described in Paragraph 2 below on or before October 31, 2022.

2. In consideration for the economic development grants provided for in this Agreement, Gambit agrees to make a minimum investment of \$2,000,000.00 in the Project Improvements, so as to add at least \$2,000,000.00 of appraised value (over the 2021 appraised value of the Premises), for ad valorem property tax purposes, as certified by the Bell County Appraisal District, to the City of Harker Heights ad valorem tax rolls beginning in the tax year 2022. Gambit agrees to provide the City with a description of the taxable improvements constructed or placed by Gambit on the Premises and to do so by the 15th day of January 2023.

Gambit further agrees to maintain taxable property of a total value of at least \$2,000,000.00 on the Premises for each of the five tax years (2022 through 2026) for which the City has agreed to provide grants under this Agreement.

3. Gambit further agrees to employ a staff described as follows beginning on or before October 31, 2022, and continuing through December 31, 2027:

- 35 servers;
- 15 bartenders;
- 6 hostesses;
- 15 cooks;
- 5 dishwashers;
- 25 event and game masters;
- 6 managers.

III.

ECONOMIC DEVELOPMENT GRANTS

1. The economic development grants to be made under this Agreement are based upon investments that Gambit agrees to make that will generate economic activity within the City and the sales activity occurring after the construction of such improvements. The City agrees to make certain economic development grants to Gambit to be calculated based upon a percentage of the ad valorem property taxes assessed by the City (and paid by Gambit) upon Project Improvements (“Property Taxes”). Further, as set forth below, the City agrees to make certain economic development grants to Gambit in amounts based upon a percentage of City sales tax revenues collected by Gambit, less any refunds by Gambit or required to be made by the City (“Sales Taxes”). Subject to the performance by Gambit of its obligations hereunder, and subject to the conditions of this Agreement, the City agrees to make the following economic development grants to Gambit:

A. GRANTS RELATING TO REAL PROPERTY IMPROVEMENTS (REAL PROPERTY ECONOMIC DEVELOPMENT GRANTS):

1. The City will make a real property economic development grant in an amount equal to 50% of the City Property Taxes timely paid by Gambit for the tax year 2022;

2. The City will make a real property economic development grant in an amount equal to 50% of the City Property Taxes timely paid by Gambit for the tax year 2023;

3. The City will make a real property economic development grant in an amount equal to 50% of the City Property Taxes timely paid by Gambit for the tax year 2024;

4. The City will make a real property economic development grant in an amount equal to 50% of the City Property Taxes timely paid by Gambit for the tax year 2025;

5. The City will make a real property economic development grant in an amount equal to 50% of the City Property Taxes timely paid by Gambit for the tax year 2026.

Grants payable hereunder shall be paid for each year of this Agreement within 45 days after Gambit has provided written notice to the City that it has made timely payment of the ad valorem property taxes assessed by the City for such year and a written request for payment of the real property economic development grant for such year. No grant payment shall be made for any year in which Gambit fails to make timely payment of property taxes and no grant shall be paid upon penalties or fees assessed because of a failure to timely pay taxes. No grant shall be paid before Gambit timely makes payment of City ad valorem property taxes.

B. GRANT CALCULATED BASED UPON SALES TAXES (SALES RELATED ECONOMIC DEVELOPMENT GRANTS):

“Gambit Net Sales Tax Revenues” as used in this Agreement shall mean City sales tax revenues collected by Gambit at its place of business in the City of Harker Heights that are remitted to and received by the City less any refunds by Gambit or refunds required to be made by the City.

1. The City will make a sales related economic development grant in an amount of 50% of the Gambit City Net Sales Tax Revenues for the year 2022;

2. The City will make a sales related economic development grant in an amount of 50% of the Gambit City Net Sales Tax Revenues for the year 2023;

3. The City will make a sales related economic development grant in an amount of 50% of the Gambit City Net Sales Tax Revenues for the year 2024;

4. The City will make a sales related economic development grant in an amount of 50% of the Gambit City Net Sales Tax Revenues for the year 2025;

5. The City will make a sales related economic development grant in an amount of 50% of the Gambit City Net Sales Tax Revenues for the year 2026.

To obtain payment of a sales related economic development grant for any year of this Agreement, Gambit shall provide notice to the City of the amount of Gambit Net Sales Tax Revenue collected by Gambit from the taxable retail sales of Gambit from the Premises in the previous calendar year and a request for payment of the sales related economic development grant. Within 30 days of receiving the request and notice, the City shall review such information and confirm the Net Sales Tax Revenue information. Gambit shall cooperate with the City to determine the amount of Net Sales Tax Revenue. The City shall make the sales related grant within 60 days after receiving Gambits’ notice and request.

IV.

REQUIREMENTS AND CONDITIONS FOR ECONOMIC DEVELOPMENT GRANTS

1. The economic development grants described herein are subject to the following requirements and conditions:

A. Project improvements with an appraised value of at least \$2,000,000.00 must be fully constructed and in place prior to October 31, 2022.

B. All construction of Project Improvements must be made in compliance with all City ordinances and state law.

C. Gambit must operate its retail business on the Premises for the entire term of this Agreement.

D. Gambit will maintain and repair all of the Project Improvements as necessary to keep the same in good working order for the entire term of this Agreement.

E. Gambit must pay all ad valorem and sales taxes prior to such taxes becoming delinquent. Gambit shall have the right to contest tax appraisals or taxes through the procedures provided by the Texas Tax Code. Gambit shall promptly pay, prior to their becoming delinquent all property taxes which it is not so contesting unless it is required by law to pay the contested taxes as a part of the contest procedure. Should Gambit contest tax appraisals or taxes, it shall notify the City of Harker Heights immediately of the contest and keep the City updated on status thereof. Such contest must be diligently pursued by Gambit. If Gambits' contest is unsuccessful, Gambit shall promptly pay any taxes and penalties/interest resulting therefrom.

F. Construction on the Project Improvements will be full completed and fully operational on or before the 31st day of October, 2022.

G. The employment requirements described in Paragraph I (3) above shall continue to be met for the entire term of this Agreement.

H. The cumulative amount of grant payments to be made under this Agreement shall not exceed \$150,299.00. Once the cumulative amount of economic development grants (real property economic development grants plus sales related economic development grants) equals \$150,299.00, the City shall have no further obligation to pay grants under this Agreement and the Agreement will terminate.

V.

COMPLIANCE

Gambit binds itself hereby to construct Project Improvements of the value and within the time frame required by this Agreement. Gambit acknowledges and agrees that the purpose of this Agreement is to encourage economic development in the City and Gambit covenants that all uses of the Premises shall be consistent with the general purpose of encouraging development

within the City during the period that this Agreement is in effect. Gambit shall comply with any reasonable request of the City for information relating to the improvements made by Gambit or compliance by Gambit of its obligations hereunder. Gambit shall cooperate in regard to any audit or inspection by the City to assure compliance by Gambit. Gambit shall also provide the City's designated employees or consultants with access to inspect the Premises to ensure that improvements as required herein are being maintained in accordance with the provisions of this Agreement. Such inspection shall not interfere with the business operations of Gambit and shall not occur more than twice per calendar year.

VI.
TERMINATION AND RECOUPMENT OF INCENTIVE

This Agreement terminates and is cancelled at the end of the contract term unless cancelled earlier as set forth below. In the event Gambit fails to maintain taxable property of a total value of at least \$2,000,000.00 as determined by the Bell County Appraisal District on the City of Harker Heights ad valorem tax rolls for any year for which the City has otherwise agreed to provide an economic development grant under this Agreement, this Agreement will terminate and be cancelled. Further, if Gambit fails to maintain the employment level for any of the positions described in paragraph II (3) above for a period of more than 30 consecutive days during the term of this Agreement, the Agreement will terminate and be cancelled. In the event this Agreement is terminated and cancelled because of the failure of Gambit maintain property values or employment levels as required by this Agreement, Gambit shall be obligated to repay and reimburse the City an amount equal to all grants which have been made pursuant to this Agreement.

VII.
TERM

Unless terminated earlier by the provisions hereof or by the parties, this Agreement shall terminate after the City has paid all economic development grants for the year 2027 as provided herein.

VIII.
ATTORNEY'S FEES

If, on account of any breach or default by Gambit on its obligations under the provisions of this Agreement, it shall be necessary for the City to employ an attorney or attorneys to enforce or defend any of its rights or remedies hereunder, should the City prevail, the City shall be entitled to all reasonable attorney's fees, costs and expenses it incurs in connection therewith.

IX.
VENUE AND CONTROLLING LAW

Texas law shall govern interpretation of this Agreement and all disputes hereunder. This Agreement is performable, and shall be performed, in Bell County, Texas. Venue to any dispute between the parties shall be in Bell County, Texas.

X.
AMENDMENT

No amendment, modification, or alterations of the terms hereof shall be binding unless the same be in writing, dated subsequent to the date of this Agreement and is duly executed by both parties.

XI.
SEVERABILITY

If any provision of this Agreement is held to be illegal, invalid, or unenforceable, such provision shall automatically be deleted from the Agreement and the legality, validity or enforceability of the remaining provisions shall not be affected.

XII.
PRIOR AGREEMENTS SUPERSEDED

This Agreement constitutes the sole and only agreement of the parties herein with respect to the subject matter hereof and supersedes any prior understanding or written or oral agreements between the parties respecting the subject matter hereof.

XIII.
NO WAIVER

No waiver by the City or Gambit of any event of default or breach of any covenant, condition or agreement herein contained shall be treated as a waiver of any subsequent default or breach of the same or any covenant, condition, or agreement.

XIV.
ASSIGNMENT

This Agreement may not be assigned by Gambit without prior written consent of the City of Harker Heights.

XV.
